ANNEXURE B - Important Guidelines to connect to the Test Environment

Trading members are requested to note the following important guidelines for connecting to Test Market.

1. Connecting through FIX Protocol (for third party CTCLs) -

Trading members/vendors, who connect to the test market can connect the usual way through the FIX and FAST protocol. There are no changes to the connectivity parameters. For connecting to test market member can subscribe to MPLS link from TCL. For further details on connectivity kindly refer circular no. NCDEX/TECHNOLOGY-040/2016/273 dated October 14, 2016. Members who have an existing MPLS connectivity to the test market, can continue using the same to access the upgraded test market.

Technical parameters for connecting through FIX and FAST protocols have been mentioned in **Annexure C** for quick reference.

2. Connecting through NEXTRA -

Members can connect to test market with exchange provided NEXTRA for dealers and corporate Managers via **Internet** mode of Connectivity **only**. Members can also use nextra_online_trade_backup and File Uploader utilities in the test market. The release version for Nextra, nextra_online_trade_backip and File Uploader is the same as in current production system.

Members are requested to refer **Annexure F** for configuration files paths of Nextra , Online Trade Backup , File Uploader

4. Access to Test Market Portal for NCFE, WebExtranet and Extranet Common -

To facilitate ease of access to NCFE, WebExtranet and Extranet Common from a common location, members can login with the following URL - <u>https://testmarket.ncdex.com/default.aspx</u> From this location, members can choose the desired links for NCFE, WebExtranet and Extranet Common to access the respective applications.

ANNEXURE D - Scope of NEXTRA, Risk Management and Clearing Front end

Following list provides an indicative list of points that members can test in the Test Environment.

NEXTRA -

- Order entry, modification, cancellation
- Order and Trade Management.
- Client code modifications on Futures and Options Instrument
- Give up approvals for Futures and Options Instrument
- Collateral limit setting for user and TM 's
- Mass order Cancellation
- Net position at member level

Risk Management -

- Entity risk status related testing (like member RRM, square off, suspend, user square off etc)
- OI monitoring related testing (from Exchange end alerts at client/member level and status updates based on that)
- Margin related testing (Initial margin, spread benefit etc)
- Square off order related testing (when in risky state acceptance of position reducing order)

NCFE -

- User Management including user creation, role management
- Breaching member level OI limit for Future/Options Instrument to test member going in square off only for that contract /symbol.
- Trades Details Tab including Fresh Position Violation, Contract Level OI, Commodity level OI Violation, View Net Position, View Online Trades, Download Trade Details
- Setting of Collateral Limits through NCFE

Members to note, that settlement and intention marking will not be available from the clearing front end in the Test Environment.

- 1. Right click on Nextra Icon placed on the Desktop and click on "open file location".
- 2. User will be able to see application installed folder.

- 3. Go to folder env and keep the config file which is downloaded from the above location.
- 4. Start the application and select the desired config File.

- 3. Replace the config file which is downloaded from the above location.
- 4. **Ex**.C:\nest_file_uploader_2.2.125.0_INET_blade_ncdex\nest_file_uploader_2.2.125.0_IN ET_blade_ncdex\Nest_File_Uploader
- 5. Start the application by clicking on **nest_file_uploader.exe** file.

Online Trade Backup Config Location -

- 1. Install the Online Trade Backup through setup for Internet channel.
- 2. Go to installed location
- Replace the config file which is downloaded from above location in installed folder.
 Ex.C:\NEXTRA_Online_Trade_Backup
- 4. Start the application by clicking on **NEXTRA_Online_Trade_Backup.exe** file.
